

TERMS AND CONDITIONS FOR ED.SQUARE TOWN CENTRE

Christmas Giveaway Competition

ELIGIBILITY

1. Subject to condition 2, this Promotion is only open to Australian residents.
2. The following are ineligible: (i) employees of Ed.Square Town Centre or any of the tenants or retailers or their staff at Ed.Square Town Centre or any of Ed.Square Town Centre's agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who Ed.Square Town Centre has previously notified is not permitted to enter Ed.Square Town Centre's promotions.
